Member must abide by all golf course rules. **All Golf (Equity & Non-Equity Members) are subject to the \$75 per month Food & Beverage Minimum. New Golf Non-Equity Members are not subject to the Food & Beverage Minimum during the first six months of their membership.**

Non-Equity Membership agreements are for 12 months from date of purchase. A \$300 cancellation fee will be assessed for the termination of the Non-Equity Membership Program.

In order for non-equity members to receive the monthly dues option, they must sign up for automatic payment with their debit or credit card. Equity members will be billed at the end of each month. Family membership includes spouse and dependent children under the age of 23 living in the same household.
